**Our Post-Election Oakland County Republican Party (OCR) Convention shall take place on Wednesday, November 30<sup>th</sup>, 2022 at 7:00pm EST at the Suburban Collection Showplace at 46100 Grand River Ave, Novi, Michigan.**

## **THE CONVENTION BUSINESS AND PURPOSE:**

The purpose of our Post Election County Convention shall be the following:

1. **Elect the new 2023-2024 Members of the OCR Executive Committee, &**
2. **The OCR will also adjust and vote to adopt our current Municipal Delegate Allotment, &**
3. **Elevate any qualified applicants for open Oakland County Precinct Delegate Positions, &**
4. **Receive a final yearend briefing from the Chair and Vice Chair.**

## **ELIGIBILITY TO SERVE ON THE OCR EXECUTIVE COMMITTEE & HOW TO APPLY:**

The Oakland County Republican Party Bylaws (**Article 3**) refer to the make-up and eligibility to serve as a Delegate-Elected Member of the Executive Committee. All Delegate Members must have been elected as a Precinct Delegate, or been on the ballot for Precinct Delegate and received a minimum of 30 votes in the most recent August Primary Election. Also, all Executive Committee Candidates must have paid membership dues to the OCR no later than the close of business on October 3rd, 2022.

Any individual who wishes to serve on the OCR Executive Committee for the 2023-2024 Term **MUST** send an email declaring their desire to serve, and the email must also include the applicant's State House District that the applicant resides in. The election of Executive Committee Members will be done by State House District. This email **MUST** be sent to the Chair at:

In accordance with Michigan Law (MCLA Sect. 168.599), and MiGOP Rules, the County Convention must be held within 30 days following a November General Election to elect a County Executive Committee.

Furthermore, in accordance with OCRP Bylaw Article 3 (Sect. 3.4 & 3.5), all Executive Committee Members are allocated and elected by State House District, and must be Precinct Delegates in 'Good Standing' and paid members of OCRP as of midnight on October 3<sup>rd</sup>, 2022.
